# 2 NOP IMPORT CERTIFICATES - NEW APPLICATION FORM

The <u>Strengthening Organic Enforcement Rule (SOE)</u> requires all organic imports into the United States to be declared as organic and associated with a NOP Import Certificate (NIC). This change will enhance traceability and oversight of organic imports into the United States and thereby make fraud more difficult. A <u>NOP Import Certificate</u> is a transaction certificate that contains detailed information about the origin and quantity of organic products being imported into the United States of America.

Since March 19th, 2024, all organic products imported to the US have to be associated with a NIC issued from the Organic Integrity Database (OID).

Not only NOP but also EU certified operations trading products within the terms of the EU-US organic equivalency arrangement have to be registered in the OID. Please find the application form for NOP Import certificates attached.
