



TRANSITION OF CONTRACT/CONTRACTUAL OBLIGATIONS TO REGULATION (EU) 2018/848

Dear valued customer.

This Customer-Information (24-11) is a follow-up letter of our latest Customer-Information "24-10-Customer Information-Kiwa BCS Öko-Garantie GmbH Transition to Compliance EU 2018-848-240830", which is important for our customers certified under our certification-scheme "BOPS" which is equivalent to EU-regulation (EC) 834/2007.

On **November 1<sup>st</sup>, 2024**, Kiwa BCS Öko-Garantie GmbH (Kiwa BCS) will start inspections in accordance with **Regulation (EU) 2018/848** on organic production and labelling. Annual inspections in accordance with "BOPS" (BCS Organic Production Standard) will stop and are not possible anymore.

The intention of this Customer-Information is to explain how to maintain valid your contractual obligations, as agreed on in your current contract under old EU-regulation (EC) 834/2007, as well under the new EU-regulation (EU) 2018/848. Our aim is to minimise the effort for you and us.

# 1 MAINTENANCE OF YOUR CONTRACTUAL OBLIGATIONS AS WELL UNDER THE NEW EU-REGULATION (EU) 2018/848 AND EXTENION OF CONTRACTUAL OBLIGATIONS

- Kiwa BCS has decided to apply the following approach to effectively assure the incorporation of your obligations according to the new Regulation (EU) 2018/848 in your existing contract under (EC) 834/2007:
- 1 Customers, already certified under (EC) 834/2007 and willing to continue certification under (EU) 2018/848, **don't need to sign a new contract** for (EU) 2018/848 with Kiwa BCS.
- 2 The **Standard Terms and Conditions** (STC) associated with your contract under the regulation (EC) 834/2007 **remain valid** as well for the new regulation (EU) 2018/848.
  - 2.1 The current version of our STC are available on our website at <u>General terms and</u> conditions, regulations and forms (kiwa.com)
- All clauses in your contract under (EC) 834/2007 will **remain valid, except** the items affected by **amendments** as follows:

- 3.1 Your contract under the regulation (EC) 834/2007 will be **amended** in clause "*Preliminary Remarks*" as follows:
  - 3.1.1. The inspection system according to Article 27 ff. of the regulation (EC) 834/2007 is replaced by regulation (EU) 2018/848.
  - 3.1.2. This means: Your certification-activities will be subject to Regulation (EU) 2018/848.
- 3.2 Your contract under the regulation (EC) 834/2007 will be amended in clause § "Scope of Contract" as follows:
  - 3.2.1. Regulation (EC) 834/2007 is replaced by Regulation (EU) 2018/848.
  - 3.2.2. This means: The new "Scope of Contract" is the certification-regime under the regulation (EU) 2018/848.
- 3.3 Your contract under (EC) 834/2007 will be **amended** in clause § "Rights and Obligations of the Operator" as follows:
  - 3.3.1. Kiwa BCS's "Declaration on Organic System Plan" (Commitment), to be signed by the customer, is included in clause § "Rights and Obligations of the Operator".
  - 3.3.2. This means:
    - 3.3.2.1. The customer undertakes to comply with the requirements of the new regulation (EU) 2018/848.
    - 3.3.2.2. The customer has to sign the new "Declaration on Organic System Plan".
    - 3.3.2.3. The customer has to sign the new "Organic System Plan" covering the relevant certification-activity.
- The amendments as described above will come into effect immediately, unless you terminate this service (existing contract) till 31<sup>st</sup> of October 2024 in written notice.

# 1.1 CONCLUSION

- Your contract under the EU-regulation (EC) 834/207 has been amended and considers now the new obligations according to the new EU-regulation (EC) 2018/848. Relevant attachments to this amended contract are:
  - "Declaration on Organic System Plan"
  - "Organic System Plan" covering your relevant certification-activity

#### What's next?

If you wish to maintain your organic certification (i.e. keep your contract with Kiwa BCS valid), there is nothing more you need to do at this stage. We will send you the latest versions of the documents before your next inspection.
